TERMS AND CONDITIONS FSS 97.05

- C) In the event a contract-employee is, or becomes, a person under investigation for a criminal offense, a person in violation of a criminal law, or a registered sex offender or predator, such fact shall not automatically exclude such contract-employee from service in or to the City. The information shall be evaluated on a case-by-case basis, considering the nature of the employment. The City reserves the right, in its sole and exclusive discretion, to reject any contract-employee based upon any lawful reason.
