Ms. Bunt stated that SHIP LHAP 2023-2026 was identical to SHIP LHAP 2020-2023 and would be presented to City Council for future consideration.

Motion by Ms. Bittar, seconded by Ms. Thibert, to approve the SHIP LHAP for Fiscal Years 2023-2024, 2024-2025, and 2025-2026 and further recommend to City Council for adoption by resolution. Motion carried unanimously.

4. Draft FY 2023-2024 Annual CDBG & HOME Action Plan

Ms. Bunt stated that the City received the funding allocation for 2023-2024 Community Development Block Grant (CDBG) and HOME Investment Partnership Program (HOME). Some of the previously recommended funding amounts by the Board had slightly changed.

Ms. Bittar felt that \$482,379 CDBG funds allocated for Goode Park improvements could be used for other more important projects.

Chair Thibert expressed support for the Bus Voucher Program with Space Coast Area Transit.

Motion by Ms. Thibert, seconded by Ms. Beard, to approve the CDBG FY 2023-2024 Draft Annual Action Plan and further recommend to City Council for adoption at their regular Council meeting on May 4, 2023. Motion carried with members voting as follows:
