RE: Recommendation of Disaster Relief Committee Executive Board

At its Regular Meeting 2023-02 held on September 12, 2023, the Disaster Relief Committee (Committee) unanimously voted to recommend a donation to two (2) organizations: 1) Family Promise of Gainesville and 2) Second Harvest Food Bank of Central Florida, in the total amount of \$2,000 (\$1,000 per organization) for assistance towards Hurricane Idalia relief efforts in the Florida Panhandle.

Staff reached out to both organizations. Second Harvest Food Bank of Central Florida advised they sent at least one tractor trailer load of family food boxes (22 pallets) to the panhandle (out of Orlando) and that they have additional food resources should they be requested by their network partner, Second Harvest Food Bank of the Big Bend in Tallahassee. Staff did not receive a response from Family Promise.

Staff is suggesting that the Committee's recommendation be modified as a donation of \$1,000 to the Second Harvest Food Bank of the Big Bend in Tallassee and to not include the donation to Family Promise of Gainesville since staff has not heard back from this organization. The City Attorney confirmed that both adjustments to the recommendation would be acceptable.

Any expenditures by the Committee require approval by the Palm Bay Municipal Foundation, Inc. (Foundation).

FISCAL IMPACT:

Total cost is \$1,000. Disaster relief funding, in the amount of \$8,220.78, is currently available through the Foundation's account.

RE: Amending the Disaster Relief Committee's Meeting Schedule

The Disaster Relief Committee (Committee) has completed the design of their webpage, marketing flyer and business card, as well as established additional criteria for their by-laws. The Committee has also implemented a funding source through VIP parking at the annual Independence Day event and are currently working on some additional funding sources.

Due to this progress, the Committee, at its Regular Meeting 2023-01, held on March 20, 2023, unanimously voted to revise Article V, Section 1, of the By-laws, to semi-annually meetings, each calendar year, or as needed more frequently. This is revised from quarterly meetings, each calendar year.

This will require an amendment to Section 2(H) of Resolution 2017-01 of the Palm Bay Municipal Foundation, Inc., establishing the Disaster Relief Committee Executive Board.

RESOLUTION 2023-01

A RESOLUTION OF THE PALM BAY MUNICIPAL FOUNDATION, INC., BREVARD COUNTY, FLORIDA, AMENDING RESOLUTION 2017-01, BY MODIFYING THE MEETING FREQUENCY OF THE DISASTER RELIEF COMMITTEE EXECUTIVE BOARD; RESCINDING RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Disaster Relief Committee Executive Board was established by the Palm Bay Municipal Foundation, Inc. on October 3, 2017, and

WHEREAS, the Palm Bay Municipal Foundation, Inc,. desires to amend the Committee's meeting schedule from quarterly to semi-annually.

NOW, THEREFORE, BE IT RESOLVED BY THE PALM BAY MUNICIPAL FOUNDATION, INC., as follows:

SECTION 1. Resolution 2017-01, Section 2(H), is hereby amended to read as follows:

"H. The Committee shall meet semi-annually, each calendar year, or as needed more frequently. The day and time of such meetings shall be determined by the Executive Board at its first meeting after passage of this Resolution. A special meeting of the Executive Board may be called by the Chairperson at any time as needed."

SECTION 2. This resolution shall take effect immediately upon the enactment date.

This resolution was duly enacted at the Special Meeting of the Palm Bay Municipal Foundation, Inc., held on October 17, 2023.
