OLD/UNFINISHED BUSINESS:

1. Approval of Affordable Housing Advisory Committee (AHAC) Report to Florida Housing Finance Corporation Due 12/30/2023.

Ms. Berardi provided a summary of AHAC Report discussion from the previous board meeting and addressed comments that were received from board members.

Ms. Beard asked for definition of affordable housing and if it included AMI (Area Median Income). Ms. Berardi responded that for State Housing Initiatives Partnership Program (SHIP) Affordable Housing, it would be below eighty percent (80%) of AMI, but the definition would depend on the type of grant.

Ms. Beard wanted to know what definition would apply to projects that did not use any grants but were applying for permit fee reduction and asked staff to provide the definition at the next meeting. She felt that more effort needed to be made to bring affordable housing projects to Palm Bay. Ms. Beard noted that the City of Melbourne had a smaller population than Palm Bay, but their number of affordable housing units was much higher.

Ms. Bittar agreed with Ms. Beard's statements and added that more education and outreach needed to be conducted for low-income residents.

Mr. Edwards advised that the Board should make a motion prior to further discussion.

Motion by Chair Thibert, seconded by Ms. Bittar, to approve AHAC Report to Housing Finance Corporation Due December 30, 2023.

Board members discussed affordable housing training.

Ms. Beard said that Florida Housing Finance Corporation and other agencies were willing to provide training for the Board members.

Ms. Bittar spoke about creating a tool to provide training and education to the public.

Ms. Thibert said that the discussion about providing these types of services to the public should be at City staff's and City Manager's level.
